FY 2021 Capital Expenditures

Dear Mayor and Alderman:

We are half way through the FY 2021 budget year and I thought this was good time to revisit some of the capital items that were included in the FY 2021 budget but were put on hold due to Covid -19. The pandemic has brought a lot of uncertainty to our economy and your department heads have done their best to limit spending during these difficult times.

Attached to this letter is the Capital Schedule that was approved as part of your FY 2021 budget process. The items that are highlighted in yellow have been approved by council and have either been paid, purchased, or are in the process of completion. All other items have been put on hold. I have reviewed this schedule with the department heads, as well as the equipment line items within their own budgets. We discussed capital items that they would like to bring before council for consideration to purchase/complete still in this current fiscal year.

I am in favor of purchasing some of the most critical items that the department heads will bring before you. Although the pandemic continues to affect some of our revenue streams, the City is fiscally stable and can afford to make some of these capital purchases this year.

Attached to this memo is a memo from the City Attorney regarding a question presented about the use of an unimproved alley.

Based on the City Attorney's recommendations in his memo, I present the following information for the Council's consideration:

- 1. Vacate any alleys which are not improved nor maintained and which are not necessary to access any existing structure:
- A) The City currently has 30 alleys that all or a portion thereof is unimproved. In addition, there are seven street right-of-ways with no improvements.
- B) The City has previously vacated approximately 2.19 miles of alleys.
- C) Alley vacations can be completed in-house by City staff on a case-by-case basis. Typically, the alley width is split in half too each adjoining property owner, with each owner receiving an average of 400sf of property.
- D) Current land value in Belvidere averages \$1.58/sf, based on Assessor's Office records.
- 2. Close the alleys that are not maintained or improved to vehicular traffic:
 - A) 36"x24" Road Closed signs are \$41.70/each and we will need 52 signs to post all of the unimproved alleys and roadways in the City.

Signs: 52 @ \$41.70/ea = \$ 2,168.40 Sign posts plus mounting hardware: 104 @ \$48.00/ea = \$4,992.00

- 3. Improve and maintain any platted alleys under its jurisdiction that it feels should remain as alleys:
 - A) The City currently has 53 alleys that are fully improved, 19 alleys that have partial improvements and 11 alleys that are unimproved.
- B) The current cost for the Street Department to construct an alley is \$24.00 per lineal foot. The cost to complete improvements for all unimproved alleys is \$155,078.00.

- C) Alley maintenance is done on an as needed basis. Funding for this work is included in the Street Department line item #01-5-310-6002, street & parking lot maintenance and materials.
- D) Past practice for improvements to vacant public right-of-way (streets) has been the property owner's responsibility. The owner/developer would be responsible to construct the minimum pavement cross-section and storm drainage in accordance with City standards. The construction would be completed by a contractor who is bonded and insured with the City. Depending on the specific improvement, the owner/developer would be entitled to a recapture for that portion of the improvement that was constructed outside the boundaries of his property.

QUESTION PRESENTED:

The issue involving unimproved alleys and vehicular traffic is convoluted. As such, I address two questions:

Is an unimproved alley, such as the one behind 1528 South State St. (the Alley), open to public use even though it is not improved with solid surface or gravel and is really only a grass field? If in fact, such an alley is an alley open to vehicle traffic, may the City close it or prohibit its use?

DISCUSSION:

The existing situation regarding the Alley, which is similar to many alleys in the City, has put the City in an awkward position. Obviously, the City has not constructed nor maintained a portion of the Alley resulting in the Ally appearing to be simply a continuation of the existing adjacent yards. It appears that the Alley was platted as public right-of-way when the subdivision was laid out. As dedicated, and presumably accepted, right-of-way, it is essentially an unmaintained City street.

The Illinois Highway Code defines a Highway in part as "...any public way for vehicular travel that has been laid out in pursuance of any law...or has been established by dedication..." (605 ILCS 5/2-202). Similarly, a roadway is defined in part as "That portion of a highway improved, designed or ordinarily used for vehicular travel, exclusive of the berm and shoulder...". (625 ILCS 5/1-179). There is no statute generally prohibiting driving on grass or an unimproved surface. However, section 11-709.1 of the Illinois Vehicle Code requires vehicles to be driven on a roadway, and only to be driven on the shoulder for stopping or accelerating from a stop to merge with traffic. (625 ILCS 5/11-709.1). Similarly, it is well known that in Illinois one must drive on the right side of the roadway with certain exceptions. (625 ILCS 5/11-701). The shoulder is that portion of the highway adjacent to the roadway. (625 ILCS 5/1-187.1). Section 11-701 of the Vehicle Code requires that vehicles shall be driven on the right side of a roadway.

From these statutes we can draw certain conclusions. First, it is not legal to drive a vehicle upon the City terrace or even park in the terrace on virtually all of our roads. Our improved roads are clearly roadways and the paved portions are the portion of the highway improved for vehicular traffic. As such, Sections 11-709.1 and 11-1304 of the Illinois Vehicle Code would prohibit driving and parking in the

terrace (at least where there is a curb as we do have an Ordinance allowing an owner to improve the terrace for parking).


This does not mean that an unimproved alley cannot be used as public right-of-way where it is *open* for the use of the public for purposes of vehicular travel (625 ILCS 5/1-126). In the past, I have indicated that an unimproved road may be closed to vehicle traffic. However, there is nothing in the state statutes or the Belvidere Municipal Code that prohibits driving on a platted street or alley (they are actually the same thing for this discussion) even if it is not improved if it is open to vehicular travel. The City of Belvidere, to the best of my knowledge, has not closed any alley in town, nor are any alleys posted as a closed road with appropriate signage.

As such, where an alley is a platted road and the City has not "closed" the road, it would be difficult to prosecute any person from utilizing the alley as a public road. This of course raises even greater questions as to the City's duty to maintain its roads (including alleys) and its liability if it fails to maintain its roads.

RECOMMENDATION: The City should either:

- 1) Vacate any alleys which are not improved nor maintained and which are not necessary to access any existing structure; or
- 2) Close the alleys that are not maintained or improved to vehicular traffic. The City could simply pass an Ordinance closing specific alleys, or parts thereof to vehicular traffic or simply vest the Public Works Director with authority to close alleys that are not improved or maintained so long as it does not prohibit access to an existing structure; or
- 3) Improve and maintain any platted alleys under its jurisdiction that it feels should remain as alleys.

The City should take one of the above actions with respect to each unimproved alley. I do not recommend the status quo of allowing unimproved alleys to remain without either improving them or at least closing them to vehicular traffic.

WHEREAS, the City has obtained appraisals (the Appraisals), prepared by Rebecca Davidson establishing the fair market value of all of the parcels to be acquired.

NOW, IT IS THEREFORE RESOLVED, by the Mayor and City Council of the City of Belvidere, Illinois as follows:

- 1) The foregoing recitals are incorporated herein as if fully set forth.
- 2) The City Council finds that it is necessary and desirable for the City to acquire the lands specified for the purpose of the Logan Avenue reconstruction and compliance with the ADA.
- 3) The Mayor, Public Works Director, and the City Attorney are authorized to negotiate and purchase the parcels described in the Attached Exhibit A at the amount identified as the fair market value set forth in the Appraisals. The Mayor is authorized to execute any contracts and necessary closing documents as approved by the City Attorney to effectuate the purchase of the parcels identified in Exhibit A.
