SECTION A

Item 1 Public Education & Outreach: BMP A-1 Distributed Paper (Resource) Material

Original Description of BMP: City newsletter articles that promote pollution prevention

Change: The City's water bills are mailed to all customers bi-monthly. We will be placing

a pollution prevention message on the bills on a quarterly basis.

SECTION B

Public Education and Outreach: The City has assembled and maintains a kiosk of information in the entry of City Hall, including stormwater and pollution prevention (A1). We have replaced the quarterly newsletter and inserts with a pollution prevention message on our water bills. The messages will appear quarterly (A1). The Kishwaukee River Clean Up Day is promoted on the local cable access channel (A3). Storm Sewer pollution prevention was discussed at the public meeting for the 2011-2012 Budget (A6).

Public Participation/Involvement: Two representatives from the City are on the Regional Storm Water Management Committee, which is tasked with developing the Boone County Comprehensive Stormwater Management Plan (B1).

Illicit Discharge Detection and Elimination: Work continues on developing our City-wide GIS database storm sewer system map. Due to budget constraints, our stated goal of 25% of the map completed per year will not be met. We have \$5,000 in the current budget for storm sewer map work (C1). The Boone County Health Department continues to inspect, review and permit septic systems within the City watershed (C2).

Construction Site Runoff Control: The Boone County Soil & Water Conservation District continues to review all subdivision plans and conducts on site inspections during construction on behalf of the City (D4, D6).

Post-Construction Runoff Control: The Belvidere/Boone County Planning Department continues to administer the Boone County Comprehensive Plan (E1). The City of Belvidere and the Boone County Soil and Water Conservation District continue to administer the regulation of storm water runoff facilities and the maximization of the water quality through the use of structural BMP's for all new developments and redevelopments (E2, E4).

Pollution Prevention/Good Housekeeping: Training of City employees in pollution prevention is ongoing (F1). The City continues to sweep streets on a regular basis, conduct the fall leaf pickup program as well as conducting a branch pickup program twice a year (F2). All fluids from City equipment maintained at the Street Department are collected and recycled (F4).

The Best Management Practices (BMP's) outlined in the City's MS4 NPDES Permit provides the necessary guidance for the City to achieve the statutory goal of reducing the discharge of pollutants to the maximum extent practicable.

Through the activities of this reporting period, the City is taking positive steps in reaching the goal.

SUMMARY OF STORM WATER ACTIVITIES 2011/2012

Public Education and Outreach:

Maintain and distribute stormwater and pollution prevention resource material for citizens.

Maintain stormwater and pollution prevention information on City's website.

Include pollution prevention messages on water billings quarterly.

Post advertisement for the annual Kishwaukee River Cleanup day on the public access cable channel prior to the event.

Public Participation/Involvement:

Attend Regional Storm Water Management Committee functions. Work release cleanup of specific areas of the City.

Illicit Discharge Detection & Elimination:

Continue creation of digital map of City storm sewer system. Continue annual inspection of outfalls.

Construction Site Runoff Control:

BCSWCD review and inspection of all development and redevelopment projects in the City.

Post-Construction Runoff Control:

Continue annual inspection of detention ponds that have been completed and accepted by the City.

Pollution Prevention/Good Housekeeping:

Continue employee training in pollution prevention. Sweep streets on a regular basis. Complete fall leaf pickup. (November) Complete branch pickup program (May/October)
