





# Detective Division General Cases



- Investigate crimes involving: Robbery, burglary, property recovery, fraud, identity theft, forgery, auto theft, traffic homicide, sex crimes and missing persons.
- Additionally, provide for secondary responses to crimes such as suicides, kidnappings, carjacking and dignitary protection.

### **Detective Division Stats**

- In 2022, the Detective Division had 136 General Case investigations compared to 154 in 2021.
- Incidents required 58 callouts of off-duty detectives for a total 248 hours compared to 60 callouts in 2021 for 286 hours.
- The Detective Division General Case Unit made
   45 arrests compared to 42 in 2021.

## Other Detective Division Stats

- There was a total of 106 Registered Sex Offenders in 2022, compared to 91 in 2021.
- In addition, there were 160 registration changes and updates.
- In 2022, the Belvidere Police Department collected \$2,560 in State mandated annual registration fees with \$905 retained by the BPD.

# State Line Area Narcotics Team

- Officer Mears was assigned to the State Line Area Narcotics Team in May, 2022.
- SLANT consists of Officers from northern Illinois and southern Wisconsin.
- SLANT Officers have jurisdiction throughout all of Illinois and portions of southern Wisconsin.

# S.W.A.T. Special Weapons and Tactics

This Unit is commanded by Sergeant Washburn.

S.W.A.T. utilizes special weapons and tactics to tactically resolve high-risk situations including, but not limited to:

- Armed barricaded subjects
- Hostage rescue
- High-risk warrant service
- Stakeouts
- Special events
- VIP protection
- Civil disorder



# S.W.A.T. Special Weapons and Tactics

S.W.A.T. consists of 9 members of the Belvidere Police Department, 3 Tactical Emergency Medics from the Belvidere Fire Department and 6 Deputies from the Boone County Sheriff's Office.



In 2022, S.W.A.T. responded to 3 callouts:

## **Crisis Negotiations Team**

The Crisis Negotiations Team consists of 3 members of the Belvidere Police Department and 2 deputies from the Boone County Sheriff's Office.

Team members assigned to this unit must initially attend a 40-hour FBI Crisis Negotiation Course which provides presentations on negotiation techniques and role-playing scenarios.

They are also required to attend the annual Illinois Crisis Negotiators Association conference where they participate in actual scenario-based training.

## **Crisis Negotiations Team**

Hostage/Crisis Negotiators are deployed to crisis situations in both Belvidere and Boone County.

# Citizens Police Academy

In 2022, the Belvidere Police Department conducted one Citizens Police Academy which was attended by a total of 20 people. This 10-week class consists of information on BPD Structure, Patrol Operations & Investigations, Gangs, Drug Operations, Crime Scene Practical Exercises and Use of Force, Patrol Tactics and SWAT as well as an E911 Center tour and K9 Demonstrations.

Anyone interested in becoming a VIPS (Volunteers in Police Service) is required to attend the Citizens Police Academy which is free of charge.





#### Neighborhood Watch Program



- Partnership established between Belvidere citizens and the Police Department
- 16 groups; A new group was formed for the Buchanan /Julien Streets area.
- Two informal groups participated in the annual National Night Out Against Crime.

#### Community Law Enforcement Officer

Officer Michelle Schwartz was appointed to the COAR(Community Outreach/Advocacy/Recovery) Team.

Services provided to the City and County include:



- ❖ Efficient referrals by law enforcement to behavioral health providers to provide citizens struggling with health disorders and symptoms
- Follow up on overdose related calls and transport for treatment
- Provide Narcan Deployment training to organizations in the community
- Constant communication provided for community resources

In 2022, there were 268 referrals to the COAR Team for behavioral health issues, 125 people trained on the use of Narcan with 147 kits distributed.





# Northern Illinois Multi-Jurisdictional Honor Guard

- The Northern Illinois Multi-Jurisdictional Honor Guard (NIMJHG)Team, a 501(C)3 organization, exists to provide proper burial rights for Peace Officers who have given the ultimate sacrifice. The Team also provides burial rights for off-duty and retired Law Enforcement Officers' deaths.
- The NIMJHG Team has been selected by the Illinois Association of Chiefs of Police as the honor guard team to respond with Illinois Concerns of Police Survivors for any Law Enforcement funeral in the State of Illinois and provide any / all support that may be needed by the agency and the family.
- The Team also provides Colors Details for memorial events at the approval of the Board.
- There are approximately 20 Law Enforcement Officers from across the Northern Illinois region who volunteer their time to recognize, preserve the memory and honor the fallen Officers.

# Northern Illinois Multi-Jurisdictional Honor Guard

The Belvidere Police Department is one of many agencies participating in this Honor Guard. In 2002, Detective Thomas Jones was assigned to this Honor Guard. His duties/assignments include O.I.C. # **Explorer Post Program**



#### Sponsored by the BPD and Boone County Sheriff's Department

- The Belvidere-Boone County Explorer Post #2009 presently has 11 members ranging in age from 14 to 20. Explorers volunteered approximately 417.5 hours of service to our community and had 100 hours of training in 2022.
- Deputy Chief Matthew Wallace and Officer Joe Danielak serve as advisors from the Belvidere Police Department. Deputy Steve Tallacksen is an advisor from the Boone County Sheriff's Department.
- The Post meets on the 3<sup>rd</sup> Thursday of every month at 6:00 pm at the Public Safety Building, in the training room. During these meetings there is generally police related training that is instructed by an officer or deputy who has experience in that particular field. Examples of this training include traffic crash investigations, traffic stop procedures, domestic disturbances, FTO Program, firing range, and police communications.
- Each Explorer is expected to attend all meetings and participate in special events throughout the year. Explorers are permitted to ride along with advisors from the city or county after completion of the Field Training Program designed for the Explorers. Explorers are issued a police style uniform that is expected to be worn at all times when participating in special events.
- Several members of the Explorer Post participated in Tobacco Compliance Checks in partnership with the Police Department and the Boone County Health Department as a result of a grant received by the Health Department from the Illinois Liquor Control Commission.

#### **NIBRS**

#### National Incident-Based Reporting System

- The NIBRS is an incident-based reporting system in which agencies collect data on each single crime occurrence. NIBRS data are received from participating local, state and federal law enforcement agencies having automated records systems.
- The NIBRS collects data on each single incident and arrest within 22 offense categories made up of 46 specific crimes called Group A offenses. For each of the offenses coming to the attention of law enforcement, specified types of facts about each crime are reported. In addition to the Group A offenses, there are 11 Group B offense categories for which only arrest data are reported.
