# MINUTES OF THE SPECIAL MEETING OF THE BOARD OF FIRE & POLICE COMMISSIONERS OF THE CITY OF BELVIDERE HELD ON MARCH 12, 2024, IN THE CITY TRAINING ROOM OF BELVIDERE FIRE STATION NUMBER 1

Fire—Authorize Agreement with eligibility test vendor: Fire Chief Schadle presented a Proposed Agreement with National Testing Network for applicant testing and screening interviews at an annual cost of \$1,750.00. All testing would be proctored online and can be done remotely. All interviews would be done online and could use pre-recorded custom questions. Interviews would then be reviewed by Fire Chief Schadle and a panel of Firefighters from the force.
