ORDINANCE

AN ORDINANCE AUTHORIZING THE SALE OF CERTAIN PERSONAL PROPERTY (CITY VEHICLES)

WHEREAS, the City of Belvidere Public Works Department is in possession of certain used vehicles, described in Exhibit A that are no longer needed or useful; and

WHEREAS, the Vehicles constitutes surplus personal property within the meaning of 65 ILCS 5/11-76-4; and

WHEREAS, the Corporate Authorities of the City find that the previously referenced Vehicles are no longer necessary or useful to or in the best interest of the City.

NOW THEREFORE IT IS ORDAINED by the CITY COUNCIL of the City of Belvidere, Boone County Illinois, as follows:

SECTION 1: The foregoing recitals are incorporated herein as if fully set forth.

SECTION 2: The Mayor, or his designee, is authorized and directed to sell the Vehicles identified in Exhibit A by any means authorized by State Statute, as well as by internet auction site, other auction methods, trade in for new vehicles or by any other commercially reasonable method.

SECTION 4: If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

SECTION 5: All ordinances or parts of ordinances inconflict herewith are hereby repealed to the extent of such conflict.

SECTION 6: This Ordinance shall be in full force and effect from and after its passage and publication in pamphlet form as required by law which publication is hereby authorized.

OM Belvidere Group has completed a watermain loop on their property to provide fire hydrant coverage of their semi-truck parking area. Due to the conflicting requirements of the IEPA and the Illinois Department of Public Health, this watermain loop needs to be part of the municipal system. Attached to this memo is the water facility easement and maintenance agreement whereby the watermain will be owned by the City and maintained by the property owner.

WATER FACILITY EASEMENT AND MAINTENANCE AGREEMENT

THIS WATER FACILITY EASEMENT AND MAINTENANCE AGREEMENT (this "Agreement") is made and entered into this _____ day of _____ 2024, by OM Belvidere Group LLC, (hereinafter referred to as "Property Owner") to and for the benefit of the CITY OF BELVIDERE, ILLINOIS (hereinafter referred to as "City").

RECITALS:

WHEREAS, Property Owner is the owner and developer of certain real property located in the City of Belvidere, Boone County, Illinois (hereinafter, the "Property"), being lot 2 of that certain Final Plat of Subdivision known as Belvidere Retail Subdivision (the Plat) and recorded with the Boone County Clerk and Recorder's Office, Boone County, Illinois on October 6, 2022 as document number 2022R05472; and

WHEREAS, the Property Owner is constructing a retail facility and truck stop upon the Property (the Project); and

WHEREAS, the City's Municipal Code and State Statute require the Project to be constructed with fire suppression systems and potable water facilities; and

WHEREAS, current regulations of the Illinois Department of Public Health (IDPH) prohibit privately owned "dead end" runs of a potable water system, including fire suppression systems and treat fire hydrants as a prohibited "dead end"; and

WHEREAS, the Property Owner is constructing a potable water main (the Main) on the Property to provide fire suppression and appurtenances, including but not limited to, fire hydrants for the Project; and

WHEREAS, the Main will provide both fire hydrant service and potable water service for the Project and if privately held would violate IDPH guidelines by creating privately owned "dead ends"; and

WHEREAS, if the City agrees to accept the Main as a part of its community water system, the Main and appurtenances would comply with IDPH guidelines; and

WHEREAS, the Property Owner desires that the City accept public dedication of the Main and appurtenances and desires to dedicate a Water Facility Easement (the Easement) to the City as described in the attached Exhibit A which is incorporated herein; and

WHEREAS, the Owner further desires to operate and maintain the Main, appurtenances, and Easement at its own cost and expense with no cost of any kind to the City, even though the Main and appurtenances will be a part of the City's public water supply system; and

WHEREAS, the Property Owner warrants, at the time of execution of this Agreement is the fee simple owner of the Main, appurtenances, and Easement as well as the Property.

NOW, THEREFORE, in consideration of the mutual covenants contained in this Agreement, and other valuable consideration, the sufficiency of which is hereby acknowledged, the Property Owner and City hereby agree as follows:

- 1.0 Recitals. The foregoing recitals are incorporated herein by this reference.
- 2.0 Property Owner Responsibilities. Property Owner shall provide and is responsible for all maintenance, repair, replacement and operation of the Main, appurtenances and Easement as shown on Exhibit A (including, but not limited to, privately owned water facilities and fire hydrants) and the Easement premises described in Exhibit A. Property Owner's responsibility includes, but is not limited to, construction, maintenance and replacement of all parts of the City's water system lying within the Easement and all fire hydrants and other appurtenances (valves, connections, etc.) connected to the water system in accordance with the reasonable directives from the City. This does not in any way limit the Property Owner from its maintenance obligations of all portions of the Property Owner's own water service lines or other water facilities.
- 3.0 <u>Easements.</u> Property Owner hereby grants and conveys to the City a perpetual, exclusive Easement, for construction, operation and maintenance of the Main and appurtenances on, over and under the real property described in Exhibit A, subject to the following conditions:
 - (A) It is understood by the Property Owner that the City shall have the right at all times to use the Easement for the purpose of inspecting, maintaining, and repairing the Main, appurtenances, and other water facilities as provided for under this Agreement.
 - (B) Property Owner shall be fully responsible for maintaining the Easement, the Main and appurtenances, as well as all privately-owned facilities in the Easement, as set forth above and shall not construct fences, walls, landscaping, structures, or other items in the Easement that would prevent maintenance and repair access to the Easement or the Main or appurtenances.
 - (C) The rights granted herein shall not be construed to interfere with or restrict the Property Owner, its heirs, executors, administrators, successors and assigns, tenants, licensees, guests or invitees from the use of the Property so long as such use does not impair the rights of access to the Main and appurtenances or interfere with the Easement hereby granted.
 - (D) The Easement, and all obligations and rights created by this Agreement, shall run with the land and apply to all fee interests now owned or hereafter acquired in the Property. As

such, each such subsequent fee interest owner of any portion of the Property shall be deemed a Property Owner under this Agreement. Further, the beneficial interest in the Easement held by the City shall extend to any future successor in interest to the City responsible for maintaining or operating the City's water system.

- 4.0 <u>City Acceptance of Easement and Main</u>. After execution of this Agreement and completion of all work necessary to complete the Main, installation of fire hydrants and other appurtenances and connection to the City's water system in accordance with the design plans approved by the City, the City agrees to accept dedication of the Easement and the Main and other appurtenances as a part of the City's potable water system.
- this Agreement, including maintenance, repair or replacement of the Main, appurtenances, or the Easement, then City shall notify Property Owner in writing. Upon receipt of the notice, Property Owner shall immediately, repair or replace the Main, appurtenances, and Easement premises, subject to the reasonable requirements of the City. Further, no notice shall be required in the event of an emergency. If Property Owner fails to cure as set forth above, or in the event or an emergency declared at the City's sole discretion, the City may (but shall have no obligation to) enforce the Maintenance Requirements with any or all of the following enforcement measures:
 - (A) <u>Corrective Action By City</u>. If Property Owner fails to maintain the Main, appurtenances, Easement or Property, or in the event of an emergency as set forth above, City may, but is not obligated to, undertake such maintenance or repair work at the sole cost of Property Owner.
 - (B) <u>Lien of Property</u>. The City may assess the Property Owner for the reasonable, cost of performing such maintenance or repair work, together with any applicable penalties. The cost and penalties shall be equally due and owing to the City from the Property Owner. The Costs and penalties shall also be a lien on the Property.
 - (C) <u>Mandamus and Enforcement.</u> The City may bring an appropriate action in any court of competent jurisdiction to enforce this Agreement, including the maintenance, repair and replacement obligations herein and the court shall order mandamus upon the Property Owner directing them to comply with the terms of this Agreement and complete any required maintenance or repairs. The City may also bring an action to recover its costs of corrective action from any of the Property Owner plus any penalties as provide herein. The Property Owner shall pay all of the City's costs incurred in enforcing this Agreement, including, but not limited to its reasonable attorney's fees.
 - **(D)** <u>Disconnection</u>. Disconnect the Main and appurtenances from the City's Water system either through closure of values or otherwise or shut off of water to the Property and Project.
- 6.0 Penalties. Any person or entity violating any provision of this Agreement or the City of Belvidere Municipal Code is guilty of an offense and shall be subject to penalties as provided City of Belvidere Municipal Code. Further, the Property Owner shall pay all of the City's costs of enforcement of this Agreement including, but not limited to, reasonable attorney's fees.


- 7.0 <u>Indemnification</u>. Property Owner shall indemnify and hold City harmless from any and all damage, loss, claims or liability of any kind whatsoever arising from the installation, maintenance, repair, operation, or use of the Main and the Easement including, but not limited to, any loss occasioned by reason of damage or injury to persons or property which may occur. In addition, Property Owner shall pay all costs and expenses involved in defending all actions arising therefrom.
- Recorded with the Boone County Clerk and Recorders Office, Boone County, Illinois, and the filing of the same shall constitute constructive notice to all heirs, successors, transferees, and assigns of the Property Owner of this Agreement. This Agreement shall run with the land and be binding upon all successors and assigns of Property Owner. This Agreement may not be amended or modified without the prior written approval of authorized officials of the City and Property Owner, and such approval must be indicated on the face of any subsequently recorded document amending or modifying this Agreement. Property Owner represents and warrants to City that the person executing this Agreement on behalf of Property Owner is fully authorized and empowered to do so by all necessary limited liability company action. Any action to enforce this Agreement shall be brought in the 17th Judicial Circuit, Boone County Illinois. The Property Owner hereby consents to jurisdiction and venue in that Court. This Agreement shall be interpreted under the laws of the State of Illinois without regard to conflicts of law provisions.

Re: Well #11 Facility Design Engineering Services

The drilling of new well #11 is scheduled to begin in mid-June. Attached to this memo is a proposal from Strand Associates, in the amount of \$397,000.00, for the engineering and design of the Well #11 facilities, including pumphouse, filtration systems, 500,000 gallon reservoir and booster pumps. The preliminary estimate of construction cost to complete this project is \$9,594,000.00. The Engineer's Design Summary Report will be submitted to the IEPA for their review and approval as part of the construction permit application. This process is expected to take ten months to complete. This project, #L17-6580, is considered phase II of our IEPA Loan Program Project. Principal forgiveness and perhaps PFAS Funding will be included in this loan also.

I would recommend approval of the Engineering Services Agreement with Strand Associates for the engineering and design of the Well #11 facilities, in the amount not-to-exceed \$397,000.00. This work will be paid for from the IEPA Loan Program.

Dear Mr. Anderson:

This letter presents a proposed scope of services and fee for the Well No. 11 well facility project. The well drilling phase of the project is underway, the City of Belvidere wishes to begin the facility design in parallel with drilling to save time on the overall schedule. This will also keep the project on course for meeting deadlines associated with the Illinois Environmental Protection Agency (IEPA) Public Water Supply Loan Program schedule. An updated schedule and preliminary opinion of probable cost (OPCC) are included in this letter.

The proposed scope of services takes the project through final design and permitting. A separate agreement will be used to cover bidding and construction-phase services.

The Well No. 11 well facility is expected to include the following major components.

- Submersible well pump and process piping
- Pressurized iron filtration system
- 500,000-gallon reservoir
- Booster pumps
- Chemical feed systems (sodium hypochlorite, fluoride)
- Electrical room
- Exterior auxiliary generator
- Architecture to blend with surrounding residential neighborhood
- Site grading, paving, and restoration

A brief preliminary design review will be used to determine equipment sizing, reservoir volume, and facility layout. The design is expected to include components similar to the City's Well No. 10 facility, including iron filtration, auxiliary generator, and residential architectural finishes. In addition, up to 500,000 gallons of ground-level storage and booster pumps will be needed to account for abandonment of the Well No. 3 facility and main plant reservoir. The preliminary design review will be summarized in a letter report to satisfy IEPA requirements for the *Engineer's Design Summary* section of the construction permit application.

Scope of Services

We propose the following scope of services for the design phase of the project.

Well Facility Design

- 1. Attend a kickoff meeting with the City to discuss facility design criteria, floor plan, site layout, and overall project goals.
- 2. Review water storage needs based on previous studies and recent water use records provided by the City.
- 3. Develop preliminary equipment sizes for the well pump, iron filter, booster pumps, chemical feed systems, electrical gear, and generator.
- 4. Finalize facility floor plan and site layout.
- 5. Prepare draft letter report to summarize conceptual design criteria and submit to the City for review and comment.
- 6. Finalize preliminary design summary.
- 7. Coordinate with City staff on the facility architectural finishes. Facility to contain the following components.
 - a. Well pump and associated piping, metering, valves, and controls to be integrated into the existing SCADA system.
 - b. Chemical feed equipment to include sodium hypochlorite for disinfection and fluoride for dental health.
 - c. Pressurized iron filtration system.
 - d. Cast-in-place concrete reservoir. Final volume as determined during preliminary design.
 - e. Booster pumps in number and capacity as determined during preliminary design three pumps assumed.
 - f. Landscaping and grading drawings.
 - g. Asphalt driveway.
 - h. Water main, sanitary sewer, and utilities within limits of the property.
 - i. Standby generator.
- 8. Coordinate with the City and its SCADA integrator to review radio path survey completed by others and incorporate survey parameters into the facility's final design.
- 9. Assist the City with procurement of geotechnical services for soil borings.
- 10. Provide architectural, civil, structural, mechanical, and electrical engineering and design services.
- 11. Submit draft drawings, preliminary site landscaping and grading drawings, pumping station elevations, and specifications to City for review.
- 12. Prepare Bidding Documents using Engineers Joint Contract Documents Committee C 700 Standard General Conditions of the Construction Contract, 2018 edition, technical specifications, and architectural, civil, structural, mechanical, and electrical engineering drawings.
- 13. Coordinate with the IEPA Public Water Supply Loan Program on requirements and schedule associated with the loan program. Incorporate loan-related language and forms into the bidding documents.
- 14. Assist the City in preparing the IEPA loan application.
- 15. Submit drawings and specifications to the IEPA for review and approval.
- 16. Prepare an OPCC.

The enclosed tentative schedule reflects typical durations for each phase of the project. Assuming the design process starts in June 2024, completion of the new well facility is expected by the fall of 2026.

Based on preliminary design criteria, the OPCC, in 2024 dollars, for the Well No. 11 treatment, storage, and pumping facility is \$9.6 million. Project costs will be evaluated in more detail during design.



Program (CRISI)

The United States Department of Transportation has issued a Notice of Funding Opportunity for their 2024 CRISI Program. To date we have secured \$1,666,279.00 in CRISI Funds for the phase I engineering and environmental review of our Appleton Road Grade Separation Project. We have applied to IDOT and ICC for additional engineering funds as well. The current cost estimate to complete the design of this project is \$3,000,000.00 and \$30,000,000.00 to construct this project. Grant applications are due by 5:00 P.M. on May 28, 2024. Attached to this memo is a proposal from Hampton, Lenzini & Renwick, our certified bridge manager, in the amount of \$14,000.00, to complete the grant application for Phase II Design Engineering and Construction Funding. Their work will include an updated cost estimate for the construction of this project.




Re: 20" Plug Valve Replacement – WWTP

Williams Brothers Construction's contract includes the replacement of a 20" plug valve that controls the flow of wastewater to and from the detention pond at the WWTP. It is a deep valve, located 20 feet below grade. During excavation for this valve replacement, groundwater was encountered prior to getting to the valve depth and conflicts with existing piping were uncovered that were not known during project design. Additional excavation, dewatering and shoring will be required to complete this work. The proposal we received from Williams Brothers Construction was \$333,693.04. They have also offered a \$10,000 credit if we remove the valve replacement from their contract. We had three area excavation firms review this project and received one proposal to complete this work.


N-Trak Group submitted a proposal, in the lump sum amount of \$75,000, to replace the 20" plug valve. Their price does not include dewatering beyond a three-inch pump. Given the nature of this project, I am including an additional \$25,000 for dewatering and \$25,000 in contingency for an estimated replacement cost not-to-exceed \$125,000.

I would recommend approval of the lump sum proposal from N-Trak Group in the amount of \$75,000 and the total estimated project cost of \$125,000 to replace the 20" plug valve at the WWTP. This work will be paid for from Line Item #61-5-820-6190.

The Illinois Passenger Rail Chicago to Rockford Service includes a station stop in Belvidere. Attached to this memo is a copy of the station location concepts prepared by IDOT. IDOT is requesting confirmation from the City for our preferred station site. In 2014, the City Council approved the location at the Whitney Boulevard right-of-way adjacent to City Hall, which will require the closing of the street. This same location today will require a variance be issued by the Union Pacific Railroad due to their design standard of 300 feet offset from crossings for a passenger platform. The proposed 380' platform will be centered on the Whitney right-of-way. I would recommend that the City Council formally approve the Whitney location of the Belvidere train station and have IDOT submit a variance request to the Union Pacific Railroad.




PA ILLINOIS PASSENGER RAIL CHICAGO TO ROCKFORD




Station Location Concepts


