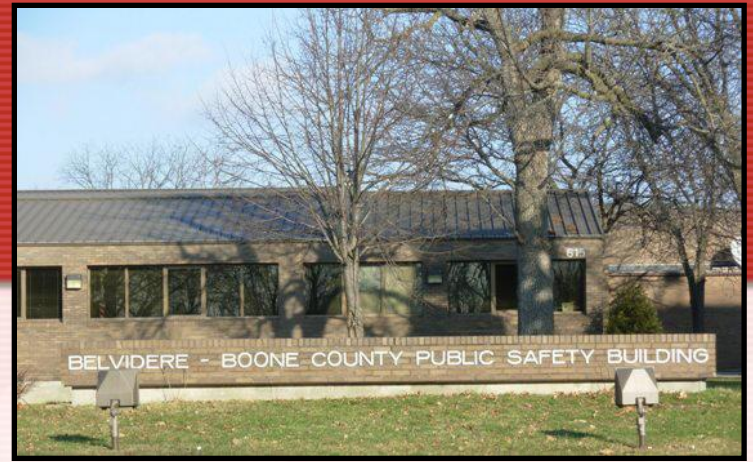

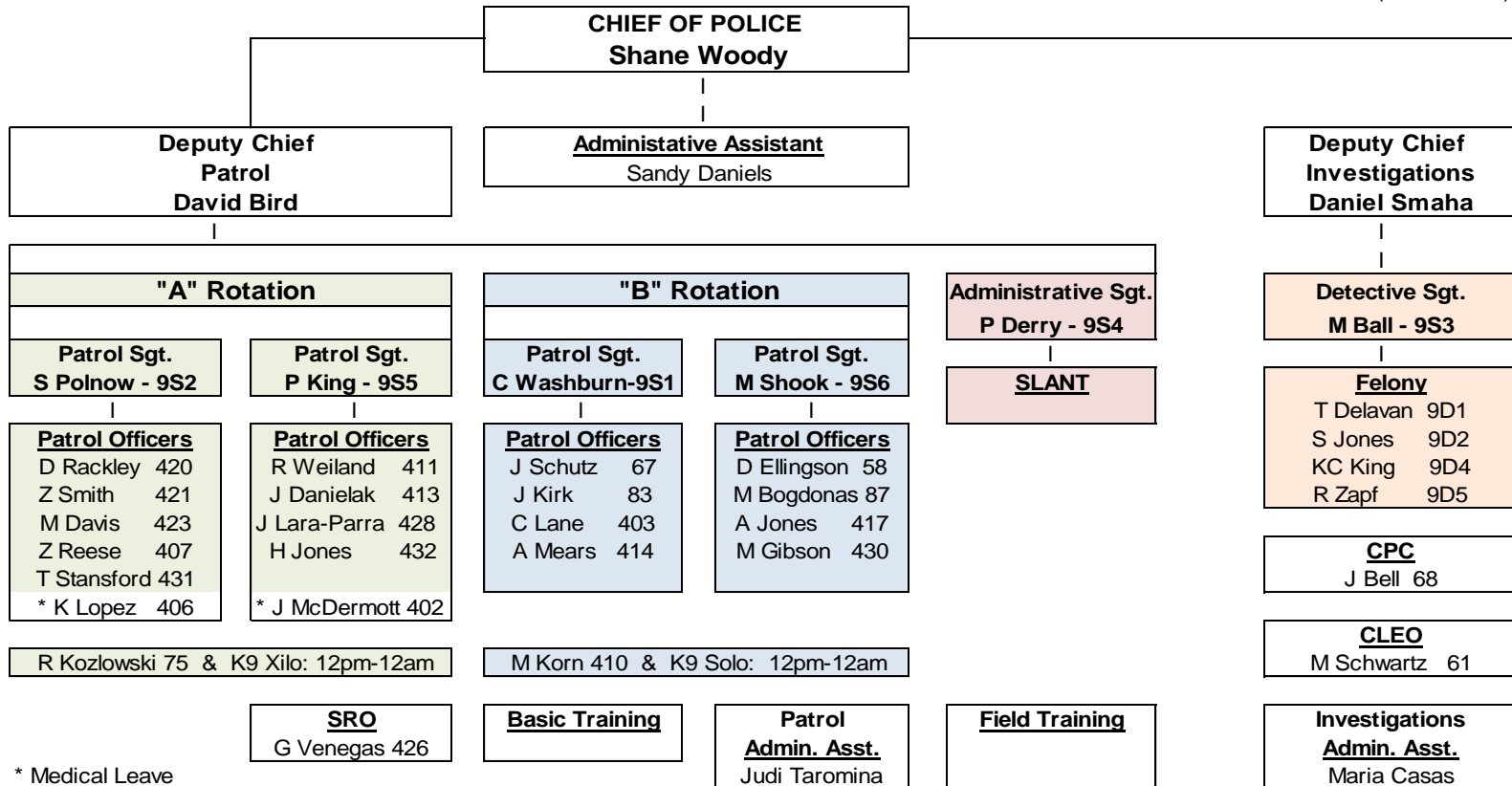

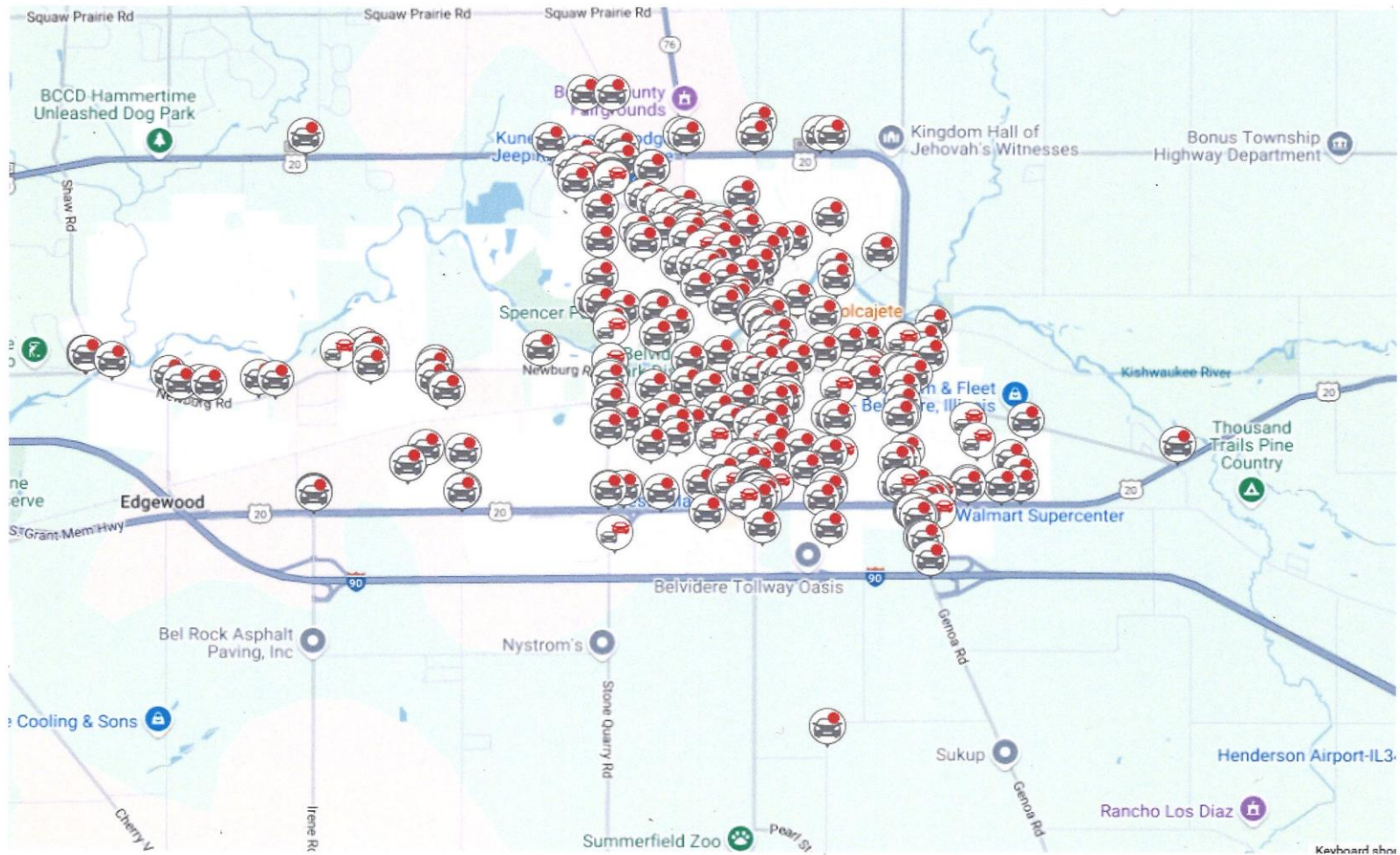
2024 Domestic Disturbances - 540

Detective Division General Cases



- Investigate crimes involving: Homicide, robbery, burglary, property recovery, fraud, identity theft, forgery, auto theft, sex crimes and missing persons.
- Additionally, provide for secondary responses to crimes such as suicides, kidnappings, carjacking and dignitary protection.

Detective Division Stats

- In 2024, the Detective Division had 148 General Case investigations compared to 146 in 2023.
- Incidents required 45 callouts of off-duty detectives for a total 178 hours compared to 57 callouts in 2023 for 228 hours.
- The Detective Division General Case Unit made 70 arrests compared to 26 in 2023.
- The Detective Division completed 86 background investigations.

Other Detective Division Stats

- **There was a total of 95 Registered Sex Offenders in 2024, compared to 107 in 2023.**
- **In addition, there were 225 registration changes and updates.**
- **In 2024, the Belvidere Police Department collected \$2,030 in State mandated annual registration fees with \$700 retained by the BPD.**

SLANT

State Line Area Narcotics Team

- **Officer Mears was assigned to the State Line Area Narcotics Team in May, 2022. In September, 2024 Officer Mears was reassigned to Patrol for shift coverage due to retirements.**
- **SLANT consists of Officers from northern Illinois and southern Wisconsin.**
- **SLANT Officers have jurisdiction throughout all of Illinois and portions of southern Wisconsin.**

Special Weapons and Tactics

S.W.A.T. consists of 9 members of the Belvidere Police Department, 3 Tactical Emergency Medics from the Belvidere Fire Department and 7 Deputies from the Boone County Sheriff's Office.



Crisis Negotiations Team

The Crisis Negotiations Team consists of 4 members of the Belvidere Police Department and 2 deputies from the Boone County Sheriff's Office.

Team members assigned to this unit must initially attend a 40-hour FBI Crisis Negotiation Course which provides presentations on negotiation techniques and role-playing scenarios.

They are also required to attend the annual Illinois Crisis Negotiators Association conference where they participate in actual scenario-based training.

Crisis Negotiations Team

Hostage/Crisis Negotiators are deployed to crisis situations in both Belvidere and Boone County.

Citizens Police Academy

The Belvidere Police Department conducts a Citizens Police Academy every year. This 10-week class consists of information on BPD Structure, Patrol Operations & Investigations, Gangs, Drug Operations, Crime Scene Practical Exercises and Use of Force, Patrol Tactics and SWAT as well as an E911 Center tour and K9 Demonstrations.

Anyone interested in becoming a VIPS (Volunteers in Police Service) is required to attend the Citizens Police Academy which is free of charge.

- ❖ Constant communication provided for community resources

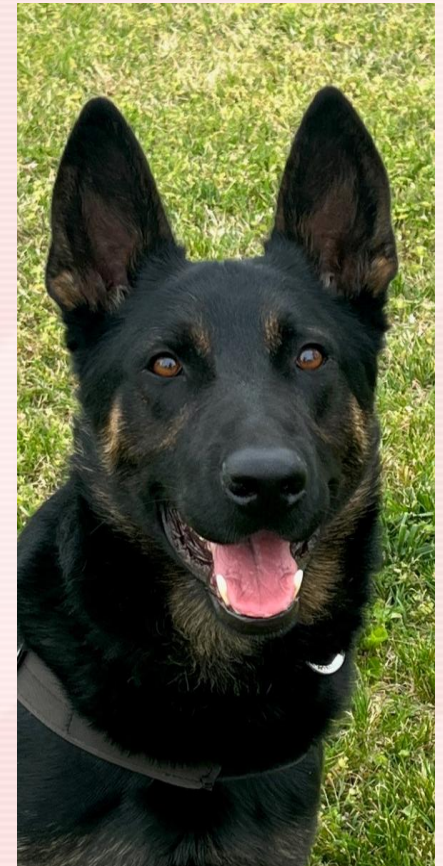
In 2024, there were 370 referrals to the COAR Team for behavioral health issues, 58 people trained on the use of Narcan with 333 kits distributed.

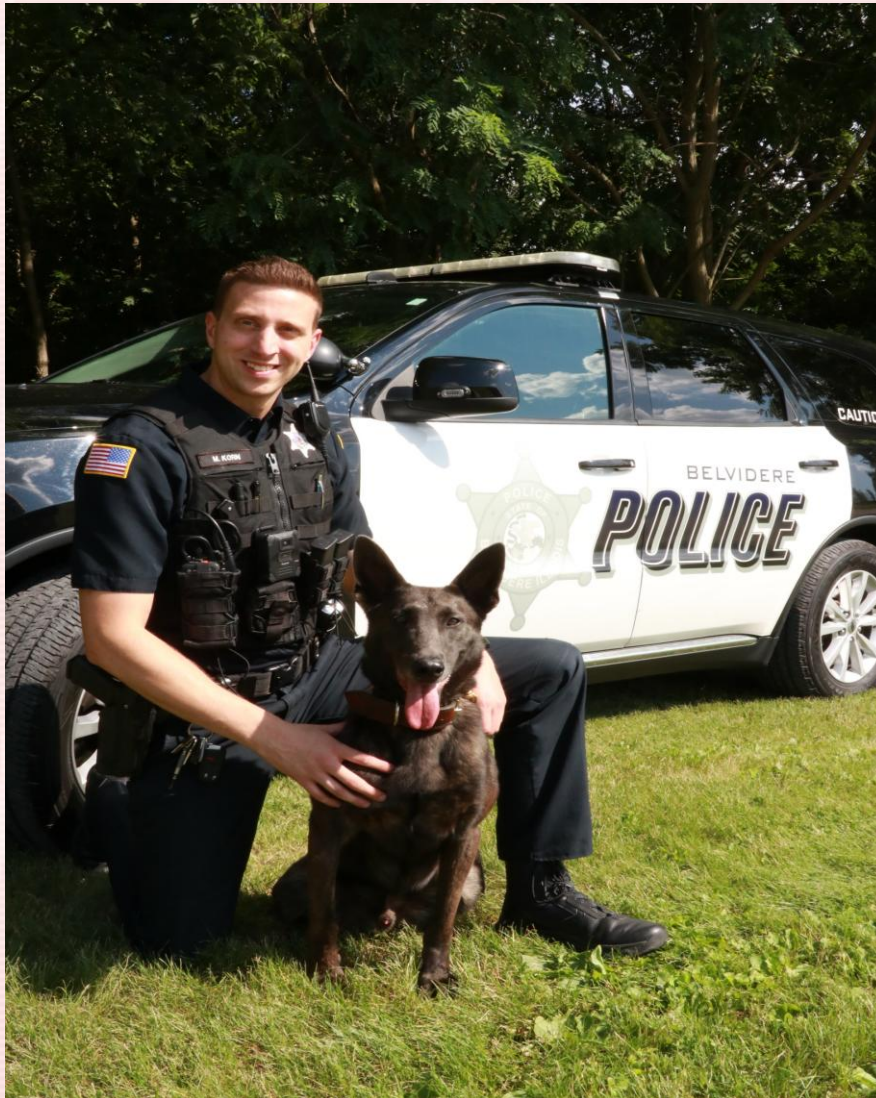

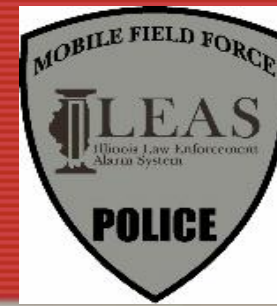

Mobile Field Force



- Mobile Field Force Teams were developed in 2005 by the ILEAS Governing Board for the primary purpose of providing security at National Pharmaceutical Stockpile distribution sites. Under the philosophy of homeland security, these teams also respond to incidents of civil disorder, disasters and out-of-state requests for assistance. Funding for training, equipment and overtime is provided by ILEAS.
- Officer Jeremy Bell, Officer Gerardo Venegas and Officer Steven Golden were assigned to this area's Mobile Field Force. Officer Bell is the Region 2 Team Commander.
- 2024 Assignments:

In addition to these events, the Region 2 team participated in six trainings over the year concentrating on advanced training for responding to civil demonstrations, riots and high profile National Security Events.

Northern Illinois Multi-Jurisdictional Honor Guard

- The Northern Illinois Multi-Jurisdictional Honor Guard (NIMJHG) Team, a 501(C)3 organization, exists to provide proper burial rights for Law Enforcement Officers (LEO) who have given the ultimate sacrifice. The Team also provides burial rights for off-duty and retired Law Enforcement Officers' deaths.
- The NIMJHG Team has been selected by the Illinois Association of Chiefs of Police as the honor guard team to respond with Illinois Concerns of Police Survivors for any Law Enforcement funeral in the State of Illinois and provide any / all support that may be needed by the agency and the family.
- The Team also provides Colors Details for memorial events at the approval of the Board of Directors.
- There are approximately 20 Law Enforcement Officers from across the Northern Illinois region who volunteer their time to recognize, preserve the memory and honor the fallen Officers.

Explorer Post Program



Sponsored by the BPD and Boone County Sheriff's Department

- **The Belvidere-Boone County Explorer Post #2009 presently has 9 members ranging in age from 14 to 20. Explorers volunteered approximately 147 hours of service to our community and had 240 hours of training in 2024.**
- **Deputy Chief Daniel Smaha and Officer Joe Danielak serve as advisors from the Belvidere Police Department. Sergeant Robert Rosenkranz is an advisor from the Boone County Sheriff's Department.**
- **The Post meets on the 3rd Thursday of every month at 6:00 pm at the Public Safety Building, in the training room. During these meetings there is generally police related training that is instructed by an officer or deputy who has experience in that particular field. Examples of this training include traffic crash investigations, traffic stop procedures, domestic disturbances, FTO Program, firing range, and police communications.**
- **Each Explorer is expected to attend all meetings and participate in special events throughout the year. Explorers are permitted to ride along with advisors from the city or county after completion of the Field Training Program designed for the Explorers. Explorers are issued a police style uniform that is expected to be worn at all times when participating in special events.**
- **Several members of the Explorer Post participated in Tobacco Compliance Checks in partnership with the Police Department and the Boone County Health Department as a result of a grant received by the Health Department from the Illinois Liquor Control Commission.**

Explorer Post Program - Activities

NIBRS

National Incident-Based Reporting System

- **The NIBRS is an incident-based reporting system in which agencies collect data on each single crime occurrence. NIBRS data are received from participating local, state and federal law enforcement agencies having automated records systems.**
- **The NIBRS collects data on each single incident and arrest within 22 offense categories made up of 46 specific crimes called Group A offenses. For each of the offenses coming to the attention of law enforcement, specified types of facts about each crime are reported. In addition to the Group A offenses, there are 11 Group B offense categories for which only arrest data are reported.**
