- (B) Motion to approve the low bid from Schroeder Asphalt Services, Inc., in the amount of \$239,460.00 for the Manhole Adjustment Project Phase 2. This work will be paid for from Capital Funds. - (C) Motion to approve the low bid from N-Trak Group, in the amount of \$869,992.71 for the Allen Street Detention Pond Project. This work will be paid for from IEPA GIGO Grant Funds and Capital Funds. Discussion took place regarding when the project will begin. It was noted work should begin in about 45 days. Discussion took place regarding the generosity of Vetcor in their donation. Roll call vote: 10/0 in favor.
