Re: West 6th Street Corridor Review

A review of the West 6th Street corridor has been completed from Pearl Street to Appleton Road and the results are as follows:

Traffic

A total of 53,682 vehicle speeds were recorded from September 8th to September 22nd along West 6th Street with the average speed at 23 mph and the 85th percentile speed at 29 mph. The highest speed recorded was 55 mph. Taking into account the on street parking and the number of access conflicts along this corridor, the posted speed limit of 25 mph is appropriate.

6th and Pearl:

Current Status: West 6th Street stops at Pearl Street.

Traffic Volume: Based on IDOT's current Traffic Volume Map, West 6th Street has an ADT of 2850 and Pearl Street has an ADT of 5750.

Accident History: Police Department records indicate that there have been five accidents at this intersection in the last five years.

Pedestrian Activity: This intersection is located in a residential neighborhood with typical pedestrian activity.

Sight Distance: No sight distance limitations noted.

6th & Union:

Current Status: Union Avenue stops at West 6th Street.

Traffic Volume: Based on IDOT's current Traffic Volume Map, West 6th Street has an ADT of 2850 and Union Avenue has an ADT of 375.

Accident History: Police Department records indicate that there have been two accidents at this intersection in the last five years.

Pedestrian Activity: This intersection is located in a residential neighborhood with typical pedestrian activity.

Sight Distance: No sight distance limitations noted.

Conclusion: Based on the above information and IDOT's "Manual on Uniform Traffic Control Devices", a four-way stop condition is not warranted at this time.

6th and Maple:

Current Status: Maple Avenue stops at West 6th Street.

Traffic Volume: Based on IDOT's current Traffic Volume Map, West 6th Street has an ADT of 2850 and Maple Avenue has an ADT of 350.

Accident History: Police-Department records indicate that there has been one accident at this intersection in the last five years.

Pedestrian Activity: This intersection is located in a residential neighborhood with typical pedestrian activity.

Sight Distance: No sight distance limitations noted.

Conclusion: Based on the above information and IDOT's "Manual on Uniform Traffic Control Devices", a four-way stop condition is not warranted at this time.

6th and 5th Ave:


