NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Belvidere as follows:

**SECTION 1:** Section 110-91, Stop Streets, of the City of Belvidere Municipal Code is hereby amended to make the intersection of 5<sup>th</sup> Street and Caswell Street a two way stop intersection as follows:

Street	Intersection	Direction	Ord. No.
Caswell Street	East 5 <sup>th</sup> Street	2 Way on Caswell St.	

**SECTION 2:** Section 110-92 of the City of Belvidere Municipal Code is amended to remove reference to a yield intersection at East 5<sup>th</sup> Street and Caswell Street.

**SECTION 3:** The Official Traffic Regulation Map shall be amended in conformance with this Ordinance.

**SECTION 4:** If any section, paragraph, subdivision, clause, sentence or provision of this Ordinance shall be adjudged by any Court of competent jurisdiction to be invalid, such judgment shall not affect, impair, invalidate or nullify the remainder thereof, which remainder shall remain and continue in full force and effect.

**SECTION 5:** All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION 6:** This Ordinance shall be in full force and effect from and after its passage and 10 days after its publication in pamphlet form as required by law which publication is hereby authorized.
